DATA CONTROLLER AND CONTACTS

TYPE OF DATA PROCESSED AND PURPOSE OF PROCESSING

"Data" means common data relating to natural persons processed by the Company, including but not limited to: navigation data, personal data, contact data, and data relating to the use of this website.

- **Data provided voluntarily by the User**

Personal data provided by users through communications sent to e-mail addresses, will be used for the sole purpose of responding to communications and/or requests received.

- **Navigation data**

The computer systems and software procedures used to operate this website acquire, during their normal operation, some Personal Data of users whose transmission is inseparable from the use of Internet communication protocols.

This is information that is not collected in order to be associated with identified Data Subjects, but which by its very nature could, through processing and association with Data held by third parties, allow users to be identified.

This category of Data includes the IP addresses or domain names of the computers used by Users who connect to the site, the URI (Uniform Resource Identifier) notation addresses of the resources requested, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters relating to the User's operating system and computer environment.

This Data is used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct operation and is deleted after processing.

The Data in question could be used to ascertain responsibility in the event of any computer crimes against our site.

PURPOSE OF PROCESSING

Technical administration and management of the operation of the website

Fulfillment of obligations provided for by regulations and applicable national and supranational legislation (tax fulfilment, administrative...)

If necessary, to ascertain, exercise or defend the Controller's rights in judicial and/or extrajudicial proceedings.



LEGAL BASIS OF THE PROCESSING

Performance of a contract to which the data subject is party

Need to fulfil legal obligations

Legitimate interest of the Controller pursuant to Article 6(1)(f) of the GDPR.



PERIOD OF STORAGE

For the duration of the navigation

Ordinary limitation period of 10 years

Personal data may be retained for the entire duration of the complaint and/or out-of-court and/or judicial proceedings until the time limit for judicial remedies and/or appeals is exhausted.

Once the aforementioned retention periods have expired, the Data shall be destroyed, erased or made anonymous, compatibly with the technical procedures of erasure and backup and with the data controller's accountability requirements.



CONFERMENT OF DATA

Browsing data are necessary in order to carry out computer and telematic protocols, therefore, failure to provide them would not allow this website to function.



RECIPIENTS OF DATA

The data may be processed by external parties acting as autonomous data controllers such as, by way of example, authorities and supervisory and control bodies. The data may also be processed, on behalf of the Company, by external parties designated as data processors (pursuant to Article 28 of the GDPR), who are given appropriate operating instructions. These subjects, by way of example, may be companies that perform the service of management and/or maintenance of the Company's website, but also subjects that provide services for the management of the information system and telecommunications networks, including electronic mail.



SUBJECTS AUTHORISED TO PROCESS DATA

The data may be processed by employees and/or collaborators of the Data Controller and/or Data Processor assigned to the pursuit of the purposes indicated above, who have been expressly authorised to process the data and who have received adequate operating instructions.



TRANSFER OF PERSONAL DATA TO COUNTRIES OUTSIDE THE EUROPEAN UNION

Personal data collected through the website will not be transferred to third countries and/or International Organisations outside the European Union.



RIGHTS OF THE DATA SUBJECT AND COMPLAINTS TO THE SUPERVISORY AUTHORITY

By contacting SIAD S.p.A. by e-mail at siad_privacy@siad.eu, the data subject may request from the Company access to the Data concerning him/her, their deletion, the rectification of inaccurate Data, the integration of incomplete Data, the deletion of Data, the limitation of processing in the cases provided for by art. 18 GDPR, as well as object to the processing carried out for legitimate interests of the data controller.

Furthermore, the data subject, in the event that the processing is based on consent or contract and is carried out by automated means, has the right to receive in a structured, commonly used and machine-readable format the Data, as well as, if technically feasible, to transmit it to another data controller without hindrance. The data subject has the right to lodge a complaint with the competent supervisory authority in the Member State where he or she normally resides or works or in the State where the alleged infringement occurred.

The data subject has the right to withdraw consent given at any time for marketing purposes and to object to the Data processed for the same purposes. This is without prejudice to the possibility for the data subject who prefers to be contacted for the aforesaid purposes exclusively by traditional means to express his/her opposition only to the receipt of communications by automated means.
